## REFUND POLICY

### School Refund Policy

Any change or cancellation must be notified in writing to SGIC by the participant. Under no circumstances are the application and registration fees refunded. If the participant registered through an agent, then the refund must be collected from the agent, and SGIC is not responsible for additional charges incurred by the agent.

### Rejected Visa

If the participant is refused a student visa by the Canadian Consulate in his/her country, the participant is entitled to a full tuition fee refund minus the registration fee of \$175 CAD and the refund processing fee of \$300 CAD. The participant must provide the original visa rejection letter from their local consulate and the refund will be processed within 45 business days. After the approval of a student visa by the Canadian Authorities, no refund will be made if the participant does not come to college or does not study due to personal reasons.

### Cancellation due to personal reasons

If the participant wishes to cancel their bookings with SGIC due to personal reasons the amount of the total cost they are entitled to a refund will depend on the level of notice given. Under no circumstances are the application and registration fees refunded. Cancellations must meet the following conditions to be considered for a refund:

- A) Over 4 months of notice: The participant will be refunded the full tuition fee, minus the application and registration fees and the refund processing fee;
- B) Between 4-3 months of notice: The participant will be refunded up to 70% of the tuition fee, minus the application and registration fees and the refund processing fee;
- C) Between 3-2 months of notice: The participant will be refunded up to 50% of the tuition fee, minus the application and registration fees and the refund processing fee;
- D) 2 months or less notice: No refund will be offered.
